The closing time for submission of proposals/quotations is **04h30 on Thursday, 23 September 2017**. Proposals/Quotations must be sealed in an envelope clearly marked with the bid number and title given above, and placed in the **bid box entrance of !Kheis Municipal Building, 97 Oranje Street , Groblershoop**, on or before the mentioned time and latest date. Telephonic, facsimile, e-mail and late submissions will not be accepted. Quotations must remain valid for a period of thirty (30) days after the closing date.

Proposals/Quotations will be opened on the same day at the Supply Chain Management Section at 11h00. Late or unmarked proposals/quotations will not be considered.

Documents may be collected during office hours after 07H30 from 15 October 2017 at the Supply chain office

The following conditions will apply:

- Prices must be firm price and valid for a period of 90 days from the date of offer
- An original Tax Clearance Certificate must be submitted
- Supplier must be registered on National Treasury Supplier Database
- A B-BBEE certificate must be submitted or sworn affidavit
- Municipal rates must not be in arrears for the last three months
- This will be evaluated in terms of the 80/20 preference point system as prescribed in the Preferential Procurement Policy Framework Act 5 of 2001 and for this purpose the enclosed forms MBD 1, MBD 3.3, MBD 4, MBD 6.1, MBD 8 and MBD 9 must be scrutinized, completed and submitted together with your tender. The successful provider will not be necessarily the highest points scorer
- No bids will be accepted from persons in the service of the State.

Bids will be evaluated according to the **80/20** preference points system. The bids are subject to the Council Supply Chain Management Policy, Preferential Procurement Policy Framework Act, 2000, and the Preferential Procurement Regulations 2017.

The Municipality does not bind itself to accept the lowest proposal/quotation or to award a contract to the Contractor scoring the highest number of points.

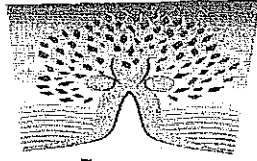
